Required documents (if available)

Copy of your last tax return (if not prepared by Colfina) and final assessment (Einschätzung or Veranlagung) by the revenue. This will be sent back to you once the current return is completed.

Original tax return forms 2025 received from the tax office.

Salary statement(s) for 2025 (annual summary only = Lohnausweis), including addendum for employee participations, if applicable.

Statements for any additional income such as secondary activity.

Costs for education and further education, if paid by yourself.

Confirmation for any income from social security, assurance, pensions etc.

Certifications of interest and balance for all bank accounts, bonds, shares, tax certificates for current account and renovation fund for apartment owners, mortgages, other debts (also tax liabilities and interest on late payment) and assets with earnings for 2025 and balance as on 31/12/25. Also bank accounts for rent deposit have to be declared. This includes foreign assets and crypto currencies.


Statements for support contributions (to persons in need of support, political party or charity organizations).

Costs for children cared for outside of your household (only if both parents are working).

Alimonies paid or received (ex-spouse or children).

Taxable value and income for real estate (notice of assessment - Steuerschätzung) and invoices for maintenance.

Tax certificates for deposits into a pillar 3A and/or voluntary payments to the pension fund BVG (in addition to the monthly pension fund contributions).

Premium for your health insurance for the whole family (just the figures): 

Medical costs which were (all together) higher than 5% of your net income and which were not refunded by any insurance. Details of a disability, diabetes or other illness, which require special treatment or diet; of any of the family members. (In Baselland all medical costs may be offset.)

Life-insurance-policies: insurer, year of issue and maturity, taxable value/surrender value, premium.

Statements for repayments (e.g. life-insurance-policies): payments from pension fund or pillar 3A, other capital payments from providence insurance or inheritances.

Do you have any other taxable assets, or did you pass on assets to someone or did you receive an inheritance or are entitled to distributions from an undistributed inheritance? Figures for any other not mentioned payments or expenses such as bank charges, custody fees etc.
